PARENTAL COVENANT AGREEMENT
(PLEASE READ CAREFULLY, SIGN AND RETURN TO SCHOOL.

In this Agreement between ABUNDANT LIFE CHRISTIAN SCHOOL and

_____, we agree to the following:
(PARENT/GUARDIAN'S NAME, hereinafter "we" or "I")

1. We believe in Christian education and are in agreement with the purpose, philosophy and intent of Abundant Life Christian School.
2. We agree to uphold and support the high academic standards of the school by providing a place at home for our child to study and to give our child encouragement in the completion of homework and assignments.
3. We understand and agree to the following financial policy:
 - a. Tuition and all fees are charged by the academic year. ***In the event that a student withdraws (except as provided in subsection d below) or is expelled during the school year, the parent/guardian is responsible for any outstanding balance owing to ALCS including the academic year's tuition and fees to be paid as scheduled or in full upon demand by ALCS.*** As a precaution, Parents may consider and purchase tuition insurance through their personal insurance provider.
 - b. Tuition for our child/children for the 20____ - 20____ will be in the amount of _____
 - c. Tuition is an annual fee. For your convenience we offer 2 options to pay tuition:
 - i. Payment in full.
 - ii. Monthly automatic debit or credit payments through the tuition acquisition company.
 - d. Students whose accounts remain delinquent will not be able to attend classes unless arrangements are made through the ALCS business office. A late fee is added on delinquent accounts. All bank fees for

check returns and/or miscellaneous fees are to be paid in full by parent/guardian.

- e. *Application and re-enrollment fees are non-refundable. The equivalent of one tenth of the annual tuition will be due and payable, or if paid will be non-refundable, for any enrolled student failing to start on the first day or withdrawing within the first ten school days. Withdrawals thereafter are subject to the above Section 3.*
 - f. *Parent/Guardian herein now states and promises to ALCS subject to immediate expulsion of Student, that Parent/Guardian does not presently owe a tuition/fees balance with any other school.*
4. We will support the school by: **involvement** in school-sponsored meetings and activities, **volunteerism** when necessary with lunch programs, fundraisers, etc. and **participation in fundraising** since tuition does not cover the entire cost of our child's education.
 5. We give permission for our child to take part in all school activities, including bus trips, sports activities and school sponsored field trips and missions' trips away from the school premises.
 6. We give permission to ALCS to use school related photos, images, videos of my child on the ALCS web site and social media which may also include Youtube uploads, Facebook, Twitter, Instagram, Google, and other social media platforms under the caption of Abundant Life Christian School and for ALCS promotional purposes. The use of my Child's image will be anonymous unless by initialing here _____, we give written permission to ALCS to not only use the image, but to also use my child's identity. We hereby fully and irrevocably release and hold harmless from all liability, loss, claims, demands and actions, and release ALCS, and its agents and affiliates from all liability, loss, claims, demands, and causes of action which I, we, my heirs, representatives, executors, administrators, or any other person acting on my behalf may have arising directly, or indirectly out of use of my child's image, pursuant to this authorization. Additionally, we will not upload any images, or videos using the ALCS name or any variation thereof without express written permission from ALCS signed by the Principal.
 7. We understand that the standards of Abundant Life Christian School do not tolerate disrespect to the personnel of the school or continued disobedience to the established policies of the school.

8. We acknowledge that there may be times when we must partner with the school in disciplining our child and agree to work with teachers and staff to honor school policies. We understand that Abundant Life Christian School will NOT administer corporeal punishment.
9. We understand and agree to pay assessments made to cover damages, at the hand of our child, to school property, including breakage of windows, awnings, furniture, Smart Boards, Textbooks, computers, and abuse of other personal property whether intentional or accidental.
10. We will faithfully support the school through our prayers and positive attitude and will not share any complaints, questionable or negative comments (regarding administration or faculty) around our child or other parents.
11. We understand and agree that our failure as parents of an ALCS student, to comply with the established regulations and discipline, Parental Covenant Agreement and financial obligations, will forfeit the student's privilege of attending Abundant Life Christian School.
12. We understand that programs are offered for care outside of school hours and do agree to abide by the policies and procedures as set forth in our Handbook.
13. Abundant Life Christian School admits students of any race, color, national and ethnic origin.

We agree to be bound by the provisions of the ALCS Handbook and ALCS Parental Covenant Agreement each academic year our child is enrolled in ALCS.
